## Ada Sentences

This study deals with syntactic and semantic analysis of *ada* sentences in standard Indonesian in the framework of Head-Driven Phrase Structure Grammar (HPSG) (Sag et al. 2003) and Minimal Recursion Semantics (MRS) (Copestake et al. 2005). The analysis will be computationally implemented in the Indonesian Resource Grammar (INDRA) (Moeljadi et al. 2015) to parse and generate sentences. *Ada* can be optionally used in quantity and locational clauses as shown in Example 1 a and 1 b; it is used in existential clauses as shown in Example 1 c, 1 d, and 1 e; and it may be used to express possession as shown in Example 1 f.

- (1) (a) Anaknya (<u>ada</u>) lima. child=3sg (ADA) five
  "His/her children are five." (based on Sneddon et al. 2010: 243)
  - (b) *Budi* (<u>ada/berada</u>) di rumah. Budi (ADA/BER-ADA) at house "Budi is at home."
  - (c) Budi <u>ada</u>.
     Budi ADA
     "Budi exists/is present."
  - (d) *Di* rumah itu <u>ada</u> seseorang. at house that ADA someone "There is someone in that house."
  - (e) <u>Ada</u> sessorang di rumah itu. ADA someone at house that "There is someone in that house."
  - (f) Budi <u>ada</u> pensil. Budi ADA pencil "Budi has a pencil."




Figure 1: Parse tree of Budi ada di rumah "Budi is at home"




Figure 2: MRS representation of Budi ada di rumah

Analysis of locational clause with ada – a locational clause has a PP as the main semantic content and an optional verb ada or berada. We treat ada and berada as auxiliaries which do not introduce a predicate of their own. The head of the subject is a noun and the head of the complement is a preposition. Figure 1 shows the parse tree of Example 1 b with an existential verb ada. In the MRS representation, the value of ARGO of the semantic head daughter  $_di_p_rel$  is an event (e2) which is equated with the INDEX. The value of its ARG1 and ARG2 refer to the value of ARGO of  $named_rel$  "budi" (x3) and  $_rumah_n_rel$  (x9) respectively, as shown in Figure 2.
